Southbridge Christian Academy Parental Agreement and Consent to Education Form

In order to solemnify the desire of the undersigned parties to glorify the Lord with their obedience to Him and to promote a clear understanding of the duties and responsibilities of each party, the undersigned parties adopt the following agreement:

Academy, do hereby accept such admission and the duties and responsibilities entailed
therein and agree to be bound by the terms of this Agreement:

1. I subscribe without reservation to the Articles of Faith and the Standards of Conduct of Southbridge Christian Academy as stated in its handbook and agree that my family will abide by these doctrines in all aspects of our lives, both at and away from school ministries and functions. I am a member of _____ Church, faithfully attending all public services and taking an active part in the total church program. I agree to be loyal to the pastor and the church programs in word and in deed. I agree to fulfill all duties and responsibilities of membership in the _____ Church.
2. I understand that Southbridge Christian Academy is an extension ministry of the church, Full Gospel Center. I understand and agree that fellowship with a local church is of utmost importance. I understand that my child *may* be expelled from the school, at the discretion of the school administration, if either of us are out of fellowship with a local church.
3. I have read and understand the *Parent-Student Handbook* and I agree with it completely. I agree that my child must abide by all of the policies, rules, and regulations of the school as listed in the *Parent-Student Handbook*. I also agree to support Southbridge Christian Academy with my prayers and services.
4. I understand and agree to uphold my responsibilities toward my children and the school by faithfully attending the required parent orientation and all parent-teacher meetings and assisting in publicizing the school and its programs among friends.
5. I understand and agree that my child will be instructed by a loving and caring staff and administration at Southbridge Christian Academy, and I will support them in their educational endeavors. I realize that from time to time children take issue with actions that they do not agree with and they are prone to criticize statements out of context. This being normal for children, I pledge that should such occur, I will not support the criticism. I will correct my child, support the school personnel, and contact staff for full details when I have questions concerning a particular incident.
6. I hereby give the staff of Southbridge Christian Academy permission to administer the following non-prescription drugs to my child(ren) at staff's discretion. I agree that the curriculum prescribed to my child by Southbridge Christian Academy was done so in order to provide my child with the highest quality education and will fulfill my purpose in obtaining a Christian as well as an academic education for my child. I will require my child to fulfill all responsibilities necessary for the completion of that prescribed course, including, but not limited to following through with any work assignments or slips to be signed. I also understand that the prescribed course and the staff or administration teaching them may change from time to time.
10. I understand and agree with Southbridge Christian Academy's discipline policy as stated in the *Parent-Student Handbook* and agree to cooperate with the staff accepting their judgment in all such disciplinary matters.
11. I agree to cooperate in the training of my child to respect school property and pay for the irregular abuse of the same.
12. I understand and agree that my child has no right to publish and distribute any literature about Southbridge Christian Academy whatsoever. This includes all online publications (website, blog, social network, etc.) as well. I understand and agree that Southbridge Christian Academy reserves the right to monitor and control, at its discretion, all materials, including but not limited to printed, audio-visual, compact disk, DVD, etc. that are published, circulated, or otherwise distributed on school grounds. I will ensure that my child understands this.
13. I understand and agree that attending Southbridge Christian Academy is a privilege, not a right, and the school reserves the right to suspend or expel any student from it for just cause, as determined by the school. This Agreement does not bind either party to any specific period of enrollment. Either party may terminate this Agreement without cause upon seven (7) days notice.
14. I am a Christian and understand that Southbridge Christian Academy is a Christian organization. Therefore I agree to follow the admonition of 1 Corinthians 6:7 and agree not to make demands, threaten to sue, or actually litigate any matter relating to or resulting from this Agreement. I also agree to be abide by the terms of Arbitration as outlined in the Parent/Student Handbook.
15. The parties agree that there are no other agreements or understandings between them relating to the subject matter of this Agreement. This Agreement supersedes all prior agreements, oral or written, between the parties and is intended as a complete and exclusive statement of the agreement of the parties. Neither this Agreement nor its execution have been induced by any reliance, representations, stipulations, warranties, agreements or understandings of any kind other than those expressed herein. If any provision of this agreement is found to be void or voidable, it shall not affect the validity of any other provision. Both parties shall remain bound by all other provisions.
